Terms & Conditions

Definition: The term 'Exhibition' shall mean Bharat Solar & EV Expo 2025. The 'Exhibitor' shall mean the party to whom space has been allotted and the term 'organizer" shall mean Bharat Solar & EV Expo 2025.

Agreement: A binding contract shall come into existence between the Exhibitor and the Organizer on acceptance of the Application form in writing by the Organizer. No Changes to these Terms shall be valid unless signed in writing by the duly authorized representatives of both parties.

Booth Allocation: Priority will be given to exhibitors in the order of application receipt, the size of the space requested, and the nature of the exhibits. The organizer has the authority to make any adjustments to booth space assigned if deemed necessary. The Exhibitor may not sublet or exchange in whole, or in part, assigned space without prior permission from the organizer.

Cancellation Terms: In case of participation cancellation, refund would be 50%, 45 days before event, after that no refund.

Rights of Organizers: The organizers reserve the following rights:

- To reject any application for space without assigning any reason thereof.
- To amend these conditions for participation and additional Rules and Regulations for participants from time to time, this shall be binding on all participants.
- To change the stand location or to make certain changes, alterations, curtailments in the final allotments of stall areas with respect to that originally booked by the exhibitor.
- To refuse permission to an exhibitor to clear his stand if he has not discharged all debts to the organizers, and to hold his exhibits or other goods as collateral security till the debts are cleared and charge demurrage and administrative charges.

Permission / Approvals: All verbal agreement, permission, individual approvals or special authorization shall be deemed to be valid only if confirmed in writing by the organizers.

Exhibition Layout: The organizer reserves the right to make amendments in the exhibition layout, including re-locating the booths; without notifying the exhibitors. The stall numbers cannot be changed even if the participant decides to shift location of the booth on the exhibition floor.

Failure of services: The organizers will use their best endeavors to ensure the supply of the services of the Expo Centre, and of the authorized contractors, but they shall not any liability to Exhibitor for any loss or damage if such services shall wholly or partially cease to be available.

Final Decision: In case of any dispute in interpretation of conditions for participation, or between exhibitors, the final decision of the Organizers namely Commerce & Industry Development Foundation, shall be binding on all parties.

Jurisdiction: The implementation of these regulations or supplementary stipulations laid down by the organizers relating to the exhibition shall be deemed to be domiciled at the office of the Delhi Courts. All disputes arising shall be judged according to Indian Laws and subject to Delhi jurisdiction only.
